It is a great honor to offer a short tribute to the late Judge Emma Shannon Walser. I had and have the highest respect and regard for her and believe that she is unparalleled in the history of our Judiciary. The state honored her when she served as the Independence Day Orator in July 2006.

As we were friends, I will refer to her as Emma, taking nothing from the esteem in which I hold her.

On a personal level, I benefited from her counsel and insight into our society. During her visits to Liberia, I was pleased that we were able to spend some time together, discussing a variety of matters and the state of the nation, while exchanging concerns and laughter. I also visited her at her home in Switzerland on one occasion.

I have used the word unparalleled and this is no exaggeration. Emma was unique. No other Liberian Judge before or since has ever stood so firm and so visibly for the right to the full full respect of individual and collective human rights. At one point in our tumultuous history, she joined a demonstration by brave young people, in her judicial robes, epitomizing the ideal that justice must be seen and felt by ordinary people. We owe her a debt of gratitude for helping many to find the courage to hold on to their own moral compass and to show solidarity with those seeking a better Liberia.

Jean and Ruby, family, we are forever grateful for the life and labor of your mother. Please accept my heartfelt condolences for your loss. May her soul Rest in Peace and Love.

- Today 27 July, the The Liberian Institute for "Growing" Patriotism (LIGP) is launching the Establishment of a series of Certificate of Patriotism including The Judge Emma Shannon Walser Medal for Rule of Law, Good Governance and Patriotism.
- The Judge Emma Shannon Walser Medal is in recognition of her 92nd Birth Anniversary on 24th July 2021 and as a tribute to her Legacy and significance for the Liberian Judiciary and legal system. She died in Switzerland on 28th May 2021 while a memorial service was held here in Liberia on 9th June.
- Judge Walser had a keen sense of justice and was well known as a Progressive and a Liberal Judge. Her father, Eugene Himie Shannon of the Grebo ethnic group was Chief Justice of the Supreme Court of Liberia.
- She was strong and would not bow to political pressure. She is known
 historically, for amongst others, standing up to the Government in the wake of
 the 1979 civil disturbances. She refused to condemn the alleged instigators of
 the 1979 Rice Riots and civil unrest.
- She was summarily dismissed for this, through a joint Resolution of the Legislature. This act promoted a cross section of Liberian Women from all sectors of society, young professionals and the Elders, amongst whom were several distinguished women as well as the leadership of the Market Women, to submit a Petition of some 500 signatories against the action, and was taken to the Legislature in protest. The matter also reached the Cabinet when President Tolbert took it there said "the women of the nation are against me".
- Even though no action ensued at the time, the impact of the Petition was felt when the framers of the 1986 Constitution subsequently prescribed that the removal of judges must be preceded by due process.
 - Reference the case of Associate Justice Cabinet M. Janneh which had
 to be accorded due process even though there were some lapses for
 which he went to the ECOWAS Court, which in turn ruled against the
 actions of the Government of Liberia.
- University student at the time, as per Ambassador Al Hassan Conteh, former President of the University of Liberia, admired the Judge and gave her the nick

- name of Shakespeare "Portia" from the Merchant of Venice, because of her sagacity and interpretation of the Law.
- Notably in 2007, the Liberian People's Party vindicated Judge Shannon Walser by characterizing her as a person who's only "Crime" was to advocate for "participatory democracy" in Liberia.
- In view of the foregoing, testimony of the caliber of the late Judge; of her impact on the legal system of Liberia, and her uncompromising stand for Justice and the Rule of Law, the Liberian Institute for "Growing" Patriotism is today establishing the: Judge Emma Shannon Walser Medal for Rule of Law, Good Governance and Patriotism.
- The recipients will be both Posthumously as well as to the Living.

 The medal for those Posthumously will be given by end of August (24th August) –one month after her 92nd birth anniversary.
- The medal for the Living will be given in December, marking the 8th anniversary of the establishment of the Liberian Institute for "Growing" Patriotism which was launched on 12th December 2013 by Ambassador Charles Minor, then Chair of the Board of Tax Appeals, on behalf of Judge Emma Shannon Walser.
- The establishment of the Medal is being undertaken by the Chair and Vice Chair of the Board of the Institute: Olubanke King-Akerele former Minister of Foreign Affairs and Sister Mary Laurene Browne, retired President of the Stella Maris Polytechnic University, with its formal launching by Sister Mary Laurene Browne, OSF.

• In her closing statement following the launch, the Executive Director and Chair of the Board of LIGP reiterated the fact that Judge Emma Shannon Walser's removal from office was a purely political move orchestrated by the Executive, devoid of the basic tenets of Liberian common law, that is "due process", it denied her a fair trial and thus her removal should be declared null and void posthumously and she be reinstated as a Judge of the Circuit Court of Liberia! The Women of Liberia will **Petition** the Legislature accordingly, as they did along the lines of their earlier Petition some 42 years ago in 1979.

 - 2. Accordingly 12 Medals were given posthumously on 9th January 2022. (Details are attached)
 - 3. Additional medals will be granted to the Living as part of International Women's Day on 8th March 2022.

III. Motivation for Establishment of the Medals.

1. The over-riding consideration for establishment of the medals is the need to **give recognition of and show appreciation to** individuals who have contributed to or are contributing to "Nation-building" through Patriotism in one

form or another. This is expected to encourage the "Growing" (development and promotion) of Patriotism amongst Liberians as there is a tendency amongst our people to be **unappreciative** and show little recognition of those who have contributed and are contributing to Nation-building – essentially to what at the bottom line is nothing short of renewal of the soul of "Mama" Liberia.

- 2. Their individual works and achievements speak to this while Sister Mary Laurene's Brief on "Growing" Patriotism (attached) captures the essence of what is meant by "Growing" (development and promotion of) Patriotism. Bearing in mind the essence of the objectives and mission of the LIGP, the mentioned should be clear.
- 3. Individuals are invited to contribute with donation of Medals by the purchase of such Medals in the U.S.A. and facilitating their onward transportation to Liberia at an overall cost of \$40.00 USD. At the Launch of Dr. Mary Antoinette Brown Sherman "Think Tank" at Kofi Annan Institute for Conflict Transformation (KAICT) at the University of Liberia on 8 March 2022, international Women's Day, yet another Posthumous presentation was made to Dr. Mary Antoinette Brown Sherman of the Judge Emma Shannon Walser medal of Rule of Law, Good Governance & Patriotism. Accepting the medal on behalf of her family was Mr. William Bloh who served as Dr. Brown Sherman special Assistant when she was President of the University of Liberia.

or Mary Antoinette Brown Sherman was born in Monrovia on October 27 1926, to Louis Arthur Grimes (former Chief Justice of the Supreme Cour of Liberia) and Victoria Elizabeth Jellemoh Cheeseman Grimes.

She graduated with a B.A. and dux of her class from Liberia College (nov University of Liberia) in 1947- a rare move for young girls at that time. She continued her education in the United States, earning an M.A. in Education from Radcliffe in 1949, and a PhD from Cornell University Itacha, in 1967, with a thesis on "Education and national development in Liberia, 1800-1900."

A professional educator, her career began as an instructor at the University of Liberia Teachers College in 1950, becoming director in 1951 and later dean of the William V.S. Tubman Teachers College (1960 to 1975). In that year, she was appointed Vice President for Academic Affair of the University, and served in that post until 1978, when she was made president of the University of Liberia by the UL Board of Trustees, the firs woman to ever hold that position in Liberia.

Dr. Sherman was a ansformational leader who was committed to quality higher education in Liberia. She assumed her position at a critical time in the history of the University, and of the nation. She provided the leadership for the process of renewal of the University, and played a decisive role in the aftermath of the 1980 coup d'état when students and professors were clamoring for social and political change and the rule o law, subsequent to the military takeover.

Source of financing for Medals

- 1. Medals: first 10 medals cost \$ 300 & were financed by "Out of pocket" resources of the Executive Director, OluBanke King-Akerele
- 2. Nephews of Executive Director (C.D.B. King III and C.T.O. King IV) are so impressed with LIGP & the concept of "Growing" Patriotism that their business (Signs etc. in Rhode Island in the USA, which produced the Medals) have decided to donate and absorb the cost of addition medals.
- 3. Son in law, Edward Neuville III (and son of late Edward Neuville, Bishop of Episcopal Diocese of Liberia) is donating additional five medals as well for medalists in 2022.
- 4. The first set of medals are all expected to be granted in early Jan. 2022
 Of these 13 will be given **posthumously** in Jan. 2022 as part of the 8th anniversary yearlong observation of LIGP
 Medals for the **Living** will be granted by July 2022, as part of our July 26 observation
- 5. Others are encouraged to support this initiative by contributions to LIGP in the name of any family member or public servants who have gone to the Great Beyond and had contributed
 - their part to "nation building". A brief on them must be provided when the support is given to LIGP.
- 6. Additional medals to be given posthumously, are planned by second half of 2022. in that connection Sister Mary Laurene, Deputy Chair of LIGP, has contributed 20 additional Medals 10 of this to be given before end of 2022 and other 10 early in New Year/2023.

The Liberian Institute for "Growing" Patriotism has been established in recognition of and as a tribute to the memory of Liberians throughout the nation, from all ethnic groups and those of settler or emigrant origins as well as Liberia's sung and unsung Heroes and Heroines from all walks of Life and all levels of society for their contributions over time, to nation-building and the development of "Mama" Liberia.

Inquirer, Wednesday, December 18, 2013 Launched of the Liberian Institute for "Growing" Patriotism

The Liberian Institute for "Growing" Patriotism has been launched with the quest of restoring the lost cultural and valued norms Liberians once enjoyed especially at the level of the leadership of government.

There has also been a call for the reintroduction of civic education that would help to justify the identity of Liberians. The institute incorporators which include former Minister of Foreign Affairs, OluBanke King-Akerele, Angie Brooks International Centre Establishment Coordinator, Cllr. Yvette Chesson-Wureh and former Minister of Information the late Emmanuel Bowier said the institute is established in recognition of and as a tribute to the memory of Liberians throughout the nation.

Cllr. Wureh said the institution comes at a time when Liberians need more ever before to add values to their lives and put the country first. She said its purpose is not to serve only working class individuals but will cut across down to the youths who are to take on the mantle of leading the country in the right direction.

She said it is only patriotism that will drive the nation to peace. Madam King said disrespect has breaded the lack of patriotism the country now suffers and that the institute is establish to address action driven development initiatives.

Madam King observed that there has been so much disrespect for Leadership in the Country but with everybody doing something to correct the wrong there will be a difference because of the generation's lack of knowledge they are full of arrogance. Former Chief Justice, Henry Reed Cooper stressed that Liberian need to begin sending their children to grade school at early ages adding that too has breaded some of the country's problem. He said those who are clothed with informing the public about what the government does or is doing need to be the right people who know what they are doing or saying and saying the truth instead of being reactionaries.

He said so many thing are being done wrongly in Liberia therefore lot needs to be changed so that patriotism can be squarely identified.

The mission of the newly launched institute is to provide informal training and education for "growing" patriotism amongst Liberians and to promote the upliftment of the welfare and wellbeing of Liberians so that they can contribute to the transformation of the Liberian society and nation-building.

Amongst other personalities who graced the launched of the institute for patriotism were University of Liberia Emmet Dennis, Madam Elizabeth Mulbah of Governance Commission, the City Mayor of Monrovia and Paynesville respectfully. Dr. Togba Nah-Tipoteh, Rev. Wah Wallace, Charles King, Caesar Morris, Rev. James Larbala and Sister Mary Laurene Brown while Mr. Charles Minor launched the institution officially on behalf of Judge Emma Shannon Walser, first female Judge of Liberia.

The institute will focus on legal advocacy, the promotion of Liberian national identity through culture and nation events, establish a private-public partnership unit for support of the Liberian economy, capacity building and research, documentation as well as the dissemination of production materials and reference books.

Each of these five pillars has a chair and co-chair, along with members working assiduously to help patriotism grow in the heart of each Liberians. We must all "Grow" Patriotism on our hearts and minds for this glorious land of Liberty, which, by God's command, shall be ours, and as a result in the words again of our National Anthem, "In Union Strong Success is sure." Celebration of the life of the late Judge Emma Shannon Walser

The memorial service of the late Judge Emma Shannon Walser was held on 9 June 2021 at the Lady of Lebanon Catholic Church on Capitol Hill, Tubman Boulevard, Monrovia, Liberia.

There has been considerable reporting on it, thanks to Togba-Nah Tipoteh's two articles in the New Democrat and the Daily Observer. As such, I will not be repeating here much of who Judge Emma Shannon Walser was about and the significance of her Judgeship and ruling for the rule of Law in Liberia.

But there was significant aspect that was not brought to light, namely the reaction by Liberian Women to the Joint Resolution by the Legislature that removed the Judge. Liberian women across the society – market women; Senior and elderly women; with young professionals (like myself at the time) constituted ourselves into a group called Concern Women for Justice. We went to the Legislature with a 500 plus signatures petition protesting the action taken to remove Liberia's first woman Circuit Court Judge of Montserrado County. It was unprecedented.

We called the media and I read the petition some 47 years ago. Leading the initiative of structuring the petition and galvanizing signatures were the Cassell Sisters (Ernestine and Clara;) Lotte-Mai Phelps – (now deceased) – and myself – Olubanke King-Akerele).

Amongst the Elders signatures were Ma Martha Johnson (Mother of Ellen Johnson Sirleaf); Jeanette Howard King (widow of President C.D.B. King); Cllr. Leona Chesson, (mother of Cllr. Yvette Chesson-Wureh and wife of the then Minister of Justice); Ma Beh, head of Liberia Market Women. We were invited into the Chambers of the Legislature by the Sargent at Arms, to present the petition.

The significance of all of this was when President Tolbert took the Petition into Cabinet and said- "the women of the country are against me." But all we wanted was Justice.

Fast forward – although the Petition did not result in the redress we expected, at the crafting of 1986 Constitution, the crafters stipulated that to remove them, judges are to be impeached thus due process must be granted for the removal of Judges. This was not done during the removal of Judge Shannon Walser, as a Joint Resolution was passed by the Legislators and she was not given the opportunity to be heard, or to defend herself.

The net result is that in the effort to remove Supreme Court Justice Kabineh Ja'neh, the legal procedure of impeachment had to be followed, even though there remained some serious issues with the other rules governing impeachment and the trial, to the extent that Justice Ja'neh took the matter to the ECOWAS Court and was vindicated about his appeal against the Liberian Supreme Court's ruling. Clearly what the Concern Women for Justice did, 47 years ago, had "seen its face."

Subsequent to this release, women of Liberia intend to follow – up with a formal Petition in concert with the Liberian nation Bar Association

to the Legislature asking for the repealing of the joint resolution or some other appropriate legal action to restore her stature. We pray that that Petition will be successful.

At the same time, we call on the Ministry of Foreign Affairs to apologize investigate and report its findings to the Family of the late Judge and to the Women of Liberia for its absence from her memorial service and not reading of the Gazette by an official of the Ministry Of Foreign Affairs as is customary and for which she was entitled.

In their absence, I had to come to the defense of the Government of Liberia, and as former Minister of Foreign Affairs, read the official Gazette in that capacity.

May the late Judge's soul rest in peace and light perpetual light shine on it.
